# BRIEF BACKGROUND OF THE INTERRELIGIOUS COUNCIL FOR PEACE TANZANIA (IRCPT)

# INRODUCTION

IRCPT is an interfaith organization made up of Member Faith Based Organization, for the purpose of enhancing peace and peaceful coexistence through constructive dialogue and collaboration. Founded and got its first registered in 1992 as *The Great Peace Journey Trust.* (GPJ) Founder Members were three Women peace activists from Christian and Muslim faiths. In 1996 religious leaders agreed to establish an interreligious council and an became an Affiliate of the World Conference on Religions for Peace International (WCRPT), now known as Religions for Peace (RfP)

In 2000, WCRPT was re-registered and extended its membership from being of individual faith people to religious institutions. From 2000 to 2010 Faith institutions engaged in building interfaith relation, conflict prevention through dialogue and jointly addressing social economic issues, engaging Women and Youth of faith for inclusivity and sustainability. In 2010 the organization gained a wider acceptance bringing Nine Religious Institutions to work together as an interfaith community.

SIGNING OF MEMORANDUM OF UNDERSTANDING (MOU)

In November 2009 Representatives from Faith Based Organizations restructured the organization to be a Member Based interreligious organization for the purpose of addressing penitent social economic issues and prevention of conflicts and religious discrimination and religious violence. In January 2010 the Name of the organization was changed from World Conference on Religions for Peace Tanzania, (WCRPT) to The Interreligious Council for Peace Tanzania, (IRCPT) and Registered with that new name.

In April 2012 Secretary Generals of Faith Based Members met with WCRPT Trustees to agree on the official adoption of IRCPT by signing of Memorandum of Understanding (MOU). The signing ceremony was done on the 12<sup>th</sup> November 2016 in Dar es Salaam.

IRCPT have interfaith structures from the national level to Ward levels, these structures are made up by religious leaders from every religious community at the regional level district, sub district and at ward levels. These structures are known as Interfaith Committees a.k.a Peace Committees.

IRCPT in collaboration with FBOs have established Women Interfaith and Youth Interfaith Networks. (TWIN and TYIN respectively).

IRCPT as many other Non Governmental Organizations was required to re- register under the NGO Act 2002; therefore on the 18<sup>th</sup> July 2019 IRCPT was registered No, NGO/R2/00099
